The Rotary Club of Altona is a Service Club and General Fund Raiser for Charities and has not registered as a GST collector. We act as your Agent for the sale of your works of art at the Art Exhibition. Under the GST Legislation, Painters/Artists and in the following categories:

**Category 1: Professional Artists who are registered as GST Collectors will charge GST and include it in their selling price. Please insert your GST Registration Number (ABN) below and be able to provide a Tax Invoice. Artists in this category must include GST in the selling price. The GST component of all sales will be collected for you to remit to the Tax Office.**

**Category 2: Professional Artists who are registered with an ABN number only. Please insert your ABN below. GST will not be charged on your works of art sales.**

**Category 3: Hobby Artists not in the Tax System will not charge GST nor will they be subject to withholding tax. For each sale we make on your behalf you will need to provide a declaration to this effect.**

### **Conditions of Entry and Sale:**

1. Each competitor may enter a maximum of six original, uncopied works and each entry must be suitably framed; name of artist and price and size of painting must be marked on the back of the painting, using the labels provided. Maximum size of paintings not to exceed 1.5 square metres.
2. Entries for the Altona/Williamstown Scene categories must be identified on the entry form by using an asterix (\*) in the small box.
3. Each artist must complete and sign an entry form and post it to **Rotary Club of Altona, PO Box 458, Laverton, Vic, 3028.** Telephone: (03) 9360 9722 with a cheque or money order at the rate of \$10.00 or \$15.00 (as per new entry costs) for each work entered. The selling price of each entry must be inclusive of GST. If a work is not selected for display, the entry fee is not refundable.
4. The Rotary Club of Altona Inc. reserves the right to exhibit such of the entries as the club may select for a period ending at 5.00pm on Sunday the 17<sup>th</sup> August 20087, and the club shall be entitled to retain 25% of such price as the selling commission to be used by the Rotary Club of Altona Inc. for charitable purposes.
5. The judge of the competition shall be as appointed by the Rotary Club of Altona Inc. The judge's decision shall be final.
6. Any damage to or loss of any exhibit, however and whenever occurring and whether whilst in transit, on display, in storage or otherwise shall be the **sole responsibility of the exhibitor.** The Rotary Club of Altona will take every care with the exhibits, but does not accept responsibility or liability for any such damage or loss and advises all exhibitors to insure against such damage or loss.
7. **SPECIAL NOTE:** Entries must be delivered free of all charges. No payments what-so-ever will be made by the Club for freight or other charges incurred in delivery or return of the entry.
8. All artwork submitted will be for competition. All artwork displayed will be for sale. No discussions will be entered into on these points.
9. Upon the announcement of the results of the competition, ALL prize winning entries become the property of the Rotary Club of Altona Inc. to distribute to our sponsors.
10. Cheques covering sales of exhibits will be posted to the address of the artist no later than twenty-one days after the close of the exhibition.
11. The price of the painting submitted on entry cannot be varied thereafter, and **NO SUBSTITUTE PAINTINGS WILL BE ACCEPTED.**
12. **ENTRY FORMS WILL NOT BE ACCEPTED AFTER MONDAY 28<sup>TH</sup> August 2009, AT CLOSE OF BUSINESS AT 5.00PM.**
